The Danella Storm Team was part of the deployment to Florida's Sanibel Island in October as part of restoration efforts after Hurricane Ian. The team was selected as one of three contractors to be part of the causeway reopening.

Ajax Paving Industries of Florida was deployed to make repairs to the hurricane-ravaged Sanibel Causeway Bridge. Ajax was part of the progressive design-build contracts that would cover both the emergency and permanent repair of the causeway. Using four roadway crews, they mobilized within 16 hours and paved 4,000 tons in two days.

Team Fishel was active in restoring power following Hurricane Ian, not only as a contractor, but also for their Teammates, families, friends, and the communities directly impacted by its wrath. This devastation affected many and they were committed to the efforts of getting every resident and business back online as quickly as possible.

Phillips & Jordan (P&J) has hauled 1.4 million cubic yards of hurricane debris following Hurricane Ian and cut 28,000 hazardous leaning trees and hanging limbs across 12 counties in Florida. They continue to support debris removal efforts and the communities affected by the disaster.

Sukut Wins Award of Merit



Sukut's 2020 Northern Branch Fire Debris and Hazardous Tree Removal project has been selected for ENR California's 2022 Regional Best Project Winner in Northern California, Award of Merit – Water/Environment category. The team contributed to the safe removal of approximately 380,000 tons of metal, concrete, ash, and contaminated soil from 2,100 parcels. In addition, 7,000 burnt vehicles were removed and recycled along with 68,000 hazard trees that were sent to sawmills and biomass facilities.



NATIONAL SUICIDE PREVENTION MONTH

September was National Suicide Prevention Month, which means many organizations and industries placed a special emphasis on mental wellbeing and suicide prevention. Suicide is a national crisis with roughly 46,000 deaths by suicide per year. That is 1 death every 11 minutes in the United States. On December 5, 2022, a 60-year-old construction site superintendent died when a dump truck backing up ran over him. He had 40 years of experience and worked for a new single-family housing construction contractor.

Best Practices

General contractors at multi-employer job sites should:

- Implement Internal Traffic Control Plans (ITCPs) and communicate to all crews as the plan changes.
- Continuously assess the hazards of vehicles to workers on foot and ensure hazards are corrected.
- Require workers to wear ANSI Class 2 high-visibility garments, such as vests, when exposed to vehicular traffic.

Employers who use dump trucks should:

- Consider installing pedestrian proximity detection systems on trucks to alert drivers of workers on foot.
- Train drivers that they must use a signaler or backup camera when backing near workers on foot.
- Create and enforce policies that:
 - Drivers establish and maintain visual contact with workers on foot. When visual contact is lost, drivers should stop and not resume movement until visual contact is re-established.
 - Workers on foot stay out of backing zones unless trained and acting as an observer signaling the driver.

National Safety Stand-Down to Prevent Falls in Construction

Fall Protection Equipment Shortage

The global supply chain constraints/issues continue to impact our industry including fall protection equipment, specifically Self-Retracting Devices (SRDs). Lead times on these products have extended out to 250 days +/- in many parts of the country.

The new standard on SRDs will be effective August 1, 2023 (ANSI/ASSP Z359.14). Some manufacturers will not be capable of being fully compliant with the new standards (unless an extension is granted). This, in turn, could potentially mean fewer compliant products available for purchase.

ACIG suggests you schedule time with your manufacturers in order to fully understand their constraints and positioning in the market and how best they can support your short-and long-term purchasing efforts.

Keystone Identification: Remember to always elevate your fall protection anchorages.

ACIG Safety/Claims Overview



ACIG's Safety/Claims Workshop was held in San Diego, CA on September 15-16, 2022.
