ACIG Financial Report June 30, 2019

Balance Sheet Profile (000's)

ACIG reported total assets of \$548,304 as of June 30, 2019 versus assets of \$498,518 reported at December 31, 2018. ACIG's shareholders' equity increased to \$195,431 as a result of strong investment performance (versus \$174,722 at December 31, 2018). ACIG adopted ASU 2016-01 effective January 1, 2019 and, as a result, holding gains for common stocks of \$13,745 (pretax) for the six months were recognized in income (versus recognition in prior years as net unrealized gains, a component of shareholders' equity). Effective January 1, 2019, ACIG reclassified \$9,145 (net of tax) of holding gains on common stocks from "net unrealized gains" to beginning retained earnings. The net unrealized appreciation for fixed income securities increased \$8,483 (net of tax) for the six months.

Operating Results for the Six Months Ended June 30, 2019 (000's)

ACIG reported pretax income of \$41,858 for the six months ended June 30, 2019 before policyholder dividends and other return premiums of \$22,686 and related bonuses of \$3,972. ACIG accrued premium refunds of \$22,686 payable to the ACIG insureds pursuant to our capital management strategy versus budgeted transactions of \$20,087. Pretax income was \$15,200, \$12,953 more than budgeted as a result of recognizing \$13,745 of holding gains for common stocks. ACIG reported net income of \$12,226 for the six months ended June 30, 2019 versus budgeted net income of \$1,969.

A.M. Best: "Captives Outperform Commercial Insurers"

Rated U.S. captive insurers continue to outperform the broader commercial insurance market, ratings agency A.M. Best Co. Inc. said in a report issued July 23, 2019. ACIG is one of approximately 200 captives that have an A.M. Best rating. The total number of captives in operation on a worldwide basis is 7,000.

According to the report, the captive market remains profitable, continuing to outperform the commercial casualty composite, with a five-year combined ratio average of 88.8% compared with 99.9% posted by its commercial casualty counterparts.

"These strong results are testament to the segment's close alignment of interests with stakeholders and deeply ingrained risk management culture," said the report.

Despite headwinds from low interest rates, changes in U.S. tax law and prolonged periods of soft market conditions, captive insurers remain nimble and stable, according to A.M. Best.






Final Thoughts

Wear Your Personal Protective Equipment (PPE)

A hundred years ago, Bullard, a Kentucky-based, family-owned business specializing in mining equipment, introduced the "Hard Boiled Hat." The original hard boiled hat was manufactured out of a steamed canvas, glue, a leather brim and black paint.

During the 1930's, Golden Gate Bridge engineer, Joseph Strauss, contacted Bullard to adapt its hats to protect bridge workers. It established the first "hard hat area". In 1938, the first Bullard aluminum hard hats could be found on construction sites. Today's hard hats are produced from polyethylene plastic, making them lightweight, durable and non-conductive to electricity with an upgraded suspension system.

Personal Protective Equipment (PPE) is the least effective of the Hierarchy of Controls.



Wear your PPE at work, on the ski slopes, while biking, motorcycling or riding a motorized scooter. Traumatic brain injuries (TBI) may affect your brain cells temporarily, while more serious TBIs can result in bruising, torn tissues and bleeding.
