ACIG Financial Report June 30, 2017

Balance Sheet Profile

ACIG reported total assets of \$503,811,000, an all-time high, as of June 30, 2017 versus assets of \$447,019,000 reported at December 31, 2016. ACIG's shareholders' equity was \$176,694,000, also an all-time high (versus \$165,733,000 at December 31, 2016). ACIG posted net unrealized gains on investments (net of tax) of \$28,525,000 at June 30, 2017, an increase of \$9,908,000 from December 31, 2016, which accounted for a substantial portion of the capital growth.

Operating Results for the Six Months Ended June 30, 2017

ACIG reported pretax income of \$30,644,000 for the six months ended June 30, 2017 before policyholder dividends and other return premiums of \$25,243,000 and related bonuses of \$4,420,000. ACIG accrued premium refunds of \$25,243,000 payable to the ACIG insureds pursuant to our capital management strategy versus budgeted transactions of \$20,679,000. ACIG reported net income of \$1,053,000 for the six months ended June 30, 2017 versus budgeted net income of \$1,787,000.

ACIG has exceeded its goal for capital growth in 2017, primarily as a result of excellent returns on ACIG's investments. ACIG has increased policyholder dividends and other return premiums to restrain capital growth.

Serious Injury and Fatality (SIF) Committee

Our SIF Committee has been charged with developing a precursor tool that is aligned with our three construction industry segments.

In addition, they will provide input and direction on the best method for communication and implementation with our Members.

ACIG's Safety Consultant will be working with our Members to complete our new Serious Injury and Fatality Prevention Survey.

Work Zone Safety

A recent Associated General Contractors of America (AGC) study found that 44% of highway contractors have experienced a vehicle crash in an active work zone. The study reported that 11% of those construction work site accidents resulted in worker fatalities and 25% left workers injured.

The AGC has launched a national advertising campaign to increase public awareness on the importance of slowing down and staying alert to the hazards while driving through a construction work zone.

Enforcement in Action – Overland Park, Kansas – police, numbering two dozen, worked to write 130 tickets and arrest 3 people during a three-hour period in the construction work zone on I-435 between I-35 and Nall Avenue. Clarkson Construction is working on this project with up to 75 workers at that site. Clarkson's Bob Fry, appearing on local television, said, "Cars have made it over the barrier before, close to where we're working, it's a big concern for us."

The fastest speeder was clocked at 95 miles per hour. He received an \$800 ticket (40 miles over x \$10), doubled for work zone.

Wagman "Goes Orange" to Support National Work Zone Safety

Wagman demonstrated their support for the 18th Annual National Work Zone Awareness Week from April 3-7, 2017. Employees were encouraged to "go orange" to help raise awareness and bring national attention to motorists and work zone safety. Wagman also coordinated a social media campaign to further increase awareness.

Mike Glezer, CEO, added "While driving through work zones, we are asking drivers to pay attention to signage and remain patient and alert. Keeping our people safe is a priority every day."


WC Medical Cost Containment Results

Concluding Thoughts

The Associated General Contractors of America (AGC) partnered with the Myers-Lawson School of Construction at Virginia Tech to prepare a comprehensive study of every construction fatality over a three (3) year period.

Some findings from their analysis:

- Falls from ladders or other structural elements account for 1/3 of U.S. construction fatalities.
- Direct construction employees accounted for 80% of construction fatalities, contract workers 20%.
- Most construction fatalities occurred at noon, the deadliest hour.
- Hispanic workers are <u>not</u> disproportionately the victim of construction fatalities. They represent 24% of the national workforce and account for 25% of all construction fatalities.
